Attached, please find the questions and the responses from the Authority in regards to the Request for Proposal of the Management and Operation of the Wildcreek Golf Course (RFP #2018-06).

The Questions received are in blue with the responses from the Authority in black.



- 1. Is it the intent of the Authority to enter into an agreement with an operator as a Licensee(lease) or Management for Fee for Wildcreek?
 - o Are you accepting bids for both and/or can you clarify?
 - Would the Authority consider a "hybrid" combination of both- For example: Enter into an initial management agreement until the ownership transfer and reconfiguration of Wildcreek is complete with the intent negotiate a Licensee agreement(lease) with Washoe County for future operations once they are determined?

The Authority intends to enter into a licensee agreement.

2. Can we get the detailed budget by department for FY17/18?

- 6. Can you provide details of the current cart fleet for the golf operation and a detailed inventory? Can you provide an overview of the condition of carts: any inoperable?
 - o Lease or owned?
 - If leased, can we get a copy of lease?
 - If owned, when were they purchased and is there a current plan for replacement?

Carts were procured in 2012, and are owned by the Authority. The batteries were replaced approximately 2 years ago.

- 7. Can we get a detailed history list of the memberships over the past three years by category?
 - Number of memberships per category and total revenue associated with each membership category?

The Authority is continuing to gather this information and it will be provided at a subsequent date.

8. Can you supply a golf course maintenance equipment inventory inclusive of hours for each machine that is applicable with a condition report for each piece(good, fair, poor, inoperable)?

Attached is a list of the equipment inventory, see Attachment A.



9. Can you provide a sample management agreement that you would suggest negotiating with new operator after the selection process?

The Authority will work with the successful proposer to develop a mutually agreed upon management agreement.

- 10. Considering the speed of transition will all current licenses be assumed by the new operator to start 4/1?
 - For example: Will the liquor license remain in place for the new operator to conduct business until the new operator has secured a new one?
 - Would a "bridge agreement" be considered until new operator had adequate time to get licenses in place to not cause any unwanted interruptions of business?

The liquor, business, and other licenses will be the responsibility of the successful bidder. If additional time is needed to secure proper licenses, the Authority will be willing to discuss options for start of the operations if delays occur.

- 11. What commitments and contracts are in place for 2018 and how will they be handled with the new operator?
 - Can you provide the detail of Memberships sold for 2018 so far?
 - o Can you provide the detail on how many golf tournaments contracts are pending and deposits received? Same for wedding and special event bookings?
 - Can you provide how much in outstanding gift card or customer credit is currently on the "books" and how this will be handled with new operator?

The Authority is continuing to gather this information and it will be provided at a subsequent date. The intent is that any outstanding "punch passes" or membership cards will be accounted for and credited with the successful proposer.

- 12. Can you provide total irrigation water used to irrigate the facility for the past three years and if there were any interruptions in service during that time that had impact to the golf course?
 - Can you provide the detailed costs associated with the use of reclaim water inclusive of rate, infrastructure payment and/or O&M fees that the new operator would be responsible for?

The Authority has an agreement in place for the City of Sparks to supply treated effluent water for the Course. The Authority pays the City of Sparks \$300,000 a year pursuant to the agreement. In the past three years there has been no interruptions in irrigation services as it relates to the delivery of treated effluent water.



13. Will the Authority be responsible for capital infrastructure of the property during the agreement: ie buildings, sewer, pump stations, irrigation system, etc?

The Authority will consider the need for capital improvements at the facility, but has no commitments to fund any capital improvements in the current or next fiscal year. With the transfer of the facility to Washoe County and the anticipation that with the sale of the 75-acre parcel to the Washoe County School District the following events may occur:

- Require de-commissioning of the existing 18-hole course and driving range, and assistance in planning related to a potential new driving range location and possible reconfiguration of additional holes as necessary for a sustainable practice course;
- The clubhouse, and associated buildings, will likely remain;
- The 9-hole par 27 course will likely remain in its current configuration;
- There may be impacts to operations, irrigation and other facilities as the construction of the new high school occurs;
- Washoe County will assume ownership of the remaining 137-acres and all golf and other facilities and equipment;
- Washoe County will assume the agreement for the management and operation of Wildcreek; and
- Washoe County will use any proceeds from the sale of the 75-acre parcel for public purposes on the remaining 137-acre parcel.

14. When will interviews be scheduled?

No date has been established, but proposers will be provided adequate notice.

15. Item "X." in RFP

- "Tab B- Financial Statement"
 - For a management firm of any significant size this would be a very lengthy request and don't believe this is the intent of the Authority. This information was also kept confidential. Would the requesting documents inclusive of profit/loss statement, balance sheet and statement of cash flows for one golf course meet this requirement?

Yes. One golf course of a similar size would suffice, we will not disclose this information.

- "Tab G-Understanding of Potential Changes to Wildcreek"
 - Who is responsible for the costs associated with the reconfiguration of Wildcreek?

Washoe County will be leading the reconfiguration of facility utilizing funds obtained from the sale of the land to the Washoe County School District.



16. Will the authority be having an official walk thru of the facility with proposers or can we schedule a time to view the property in detail(1-2 hour site inspection of the facility)?

There is no scheduled "walk thru" for the facility. The facility is a public course and proposers are welcome to schedule a time to view the facility, please contact Jose Martinez at 775-673-3199.

17. When will answers to these questions be issued?

18. How much are the water costs (per 1000 gallons or acre foot) associated with the property? Is all the water effluent?

The current cost of effluent is paid to the City of Sparks at a set \$300,000 per year.

19. What are the current cost of utilities associated with the property?

21. Is the current cart fleet staying?

22. Is the maintenance building going to stay?

At this time it is anticipated that the maintenance building will remain.



23. To what extent do you believe the irrigation system/irrigation wiring might be affected during construction? Could we have a situation where we have no access to irrigation?

With the construction, there is a potential impact to the irrigation system. This will have to be coordinated once it is determined the actual impact and the timing of the construction.

24. Will all maintenance equipment stay? For how long? Are there any costs with keeping current maintenance equipment?

25. Can we tour the facility?

26. What amount of money is going to be budgeted toward "new driving range and possible reconfiguration of additional holes"?

An actual amount has not been determined, as appraisal of the land and water rights will determine the amount available for potential use, no commitment has been made to the actual amounts committed. Please see Washoe County Board of Commissioners meeting of December 12, 2017.
