He stated that RSCVA staff recommends bringing the management of the four facilities in-house.

F2. Increase President/CEO Signature Authority

Charles Harris, President & CEO, presented this item. Mr. Harris stated that RSCVA staff is asking for approval to increase the signature authority of the President/CEO when entering into contracts with third parties. He added that the existing policy permits the President/CEO to execute contracts involving the expenditure of RSCVA funds of up to Fifty Thousand Dollars (\$50,000). He stated that the board is being asked to approve an increase in the signature authority of up to One Hundred Thousand Dollars (\$100,000) without the necessity of obtaining Board authorization.

I am unable to attend the RSCVA board meeting scheduled for 9:00 am on Thursday, September 23, 2021. I wish to have the following public comment entered into the meeting records:

In regard to President/CEO Charles Harris' compensation, the RSCVA board is planning to discuss, consider, and may take possible action to award a bonus up to \$57,776 and/or award a merit increase in Mr. Harris' base salary. I vehemently urge the board to not award a performance bonus or merit increase to Mr. Harris for the following reasons:

In an interview with the Reno Gazette-Journal, published October 14, 2020, Mr. Harris stated time and again that his number one priority as RSCVA President./CEO is to build relationships. Whether it be vendors, coworkers, board members, or the Reno-Sparks community, Mr. Harris made "relationships" a cornerstone of his identity and responsibilities. During the COVID-19 pandemic, RSCVA staff and executives were forced to take pay cuts of 10-15%, while the newly-hired Mr. Harris had a contract that excluded him from the pay cuts. As a highly-compensated employee, Mr. Harris could have reduced his exorbitant salary in a show of solidarity, but chose not to. This does not sound like the behavior of a person who strives to build relationships.

In late 2020, after receiving better-than-expected income from tourism in the area, it was suggested by Mayor Scheive that some of RSCVA's eight million dollar budget surplus be used to pay back wages for RSCVA staff that had taken these pay cuts. The total amount of back pay was stated to be \$188,000. Mr. Harris had the opportunity to give this money back to his staff, but made the decision to not add the item into the budget. Again I must state that Mr Harris' actions do not seem to be the actions of someone who claims building relationships with people are his number one priority.

Mr. Harris is already one of the highest-compensated public officials in Northern Nevada, making more in outright compensation and perks than many high-profile government employees, such as Governor Sisolak. Mr. Harris does not need a merit increase or a bonus, and that money should instead go to the RSCVA employees that make significantly less than he does.

It is my understanding that the CEO, Charles Harris is asking for a \$57,000 bonus.

I would like to remind the board that Charles is the highest paid government official in Washoe County, despite only 7 months of experience in his role, and being wholly underqualified for his position.

I would also like to remind the board that Charles refused a pay-cut that was mandated for all RSCVA employees.

\$57,000 is approaching the average HOUSEHOLD income for US citizens. Even ignoring that Charles is greatly overcompensated for his position, it is unfathomable that such a bonus would be considered when other RSCVA employees have been living on reduced pay.

There is a growing divide in our country that is heavily driven by extreme income disparities. Please do not contribute to this problem by giving money to somebody who clearly does not deserve it.
