Room Statistics Compared to the Prior Year

Taxable room revenues for the month of September 2022 are \$49,633,932 and are above September of the prior year by \$8,681,803 (21.2%). Cash occupied room nights of 302,838 are above prior year by 8,789 (3.0%). Comp occupied room nights of 80,337 are above prior year by 10,498 (15.0%), and 28-day occupied room nights of 91,008 are below prior year by 6,145 (-6.3%). Total occupied rooms for the month of September 2022 (Cash, Comp, 28-day) are 13,142 (2.9%) above the prior year.

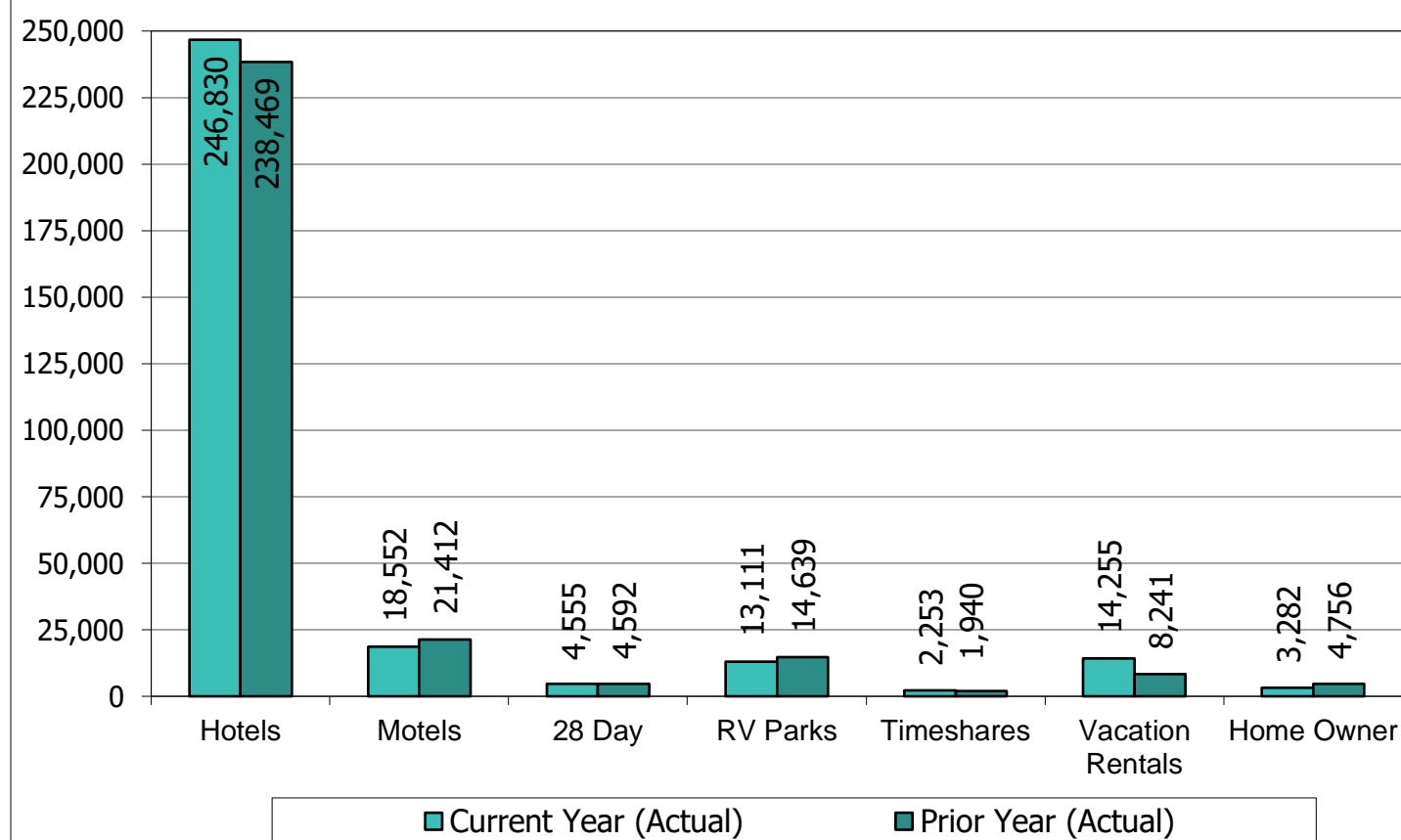
Overall, the Washoe County occupancy percentage of 71.6% for the month is 2.9% above the 68.7% level of the prior year. There were 8,610 (-1.3%) less available rooms for the month compared to the prior year.

Overall cash average rates for September 2022 of \$163.90 increased \$24.63 (17.7%), compared to \$139.27 for the prior year.

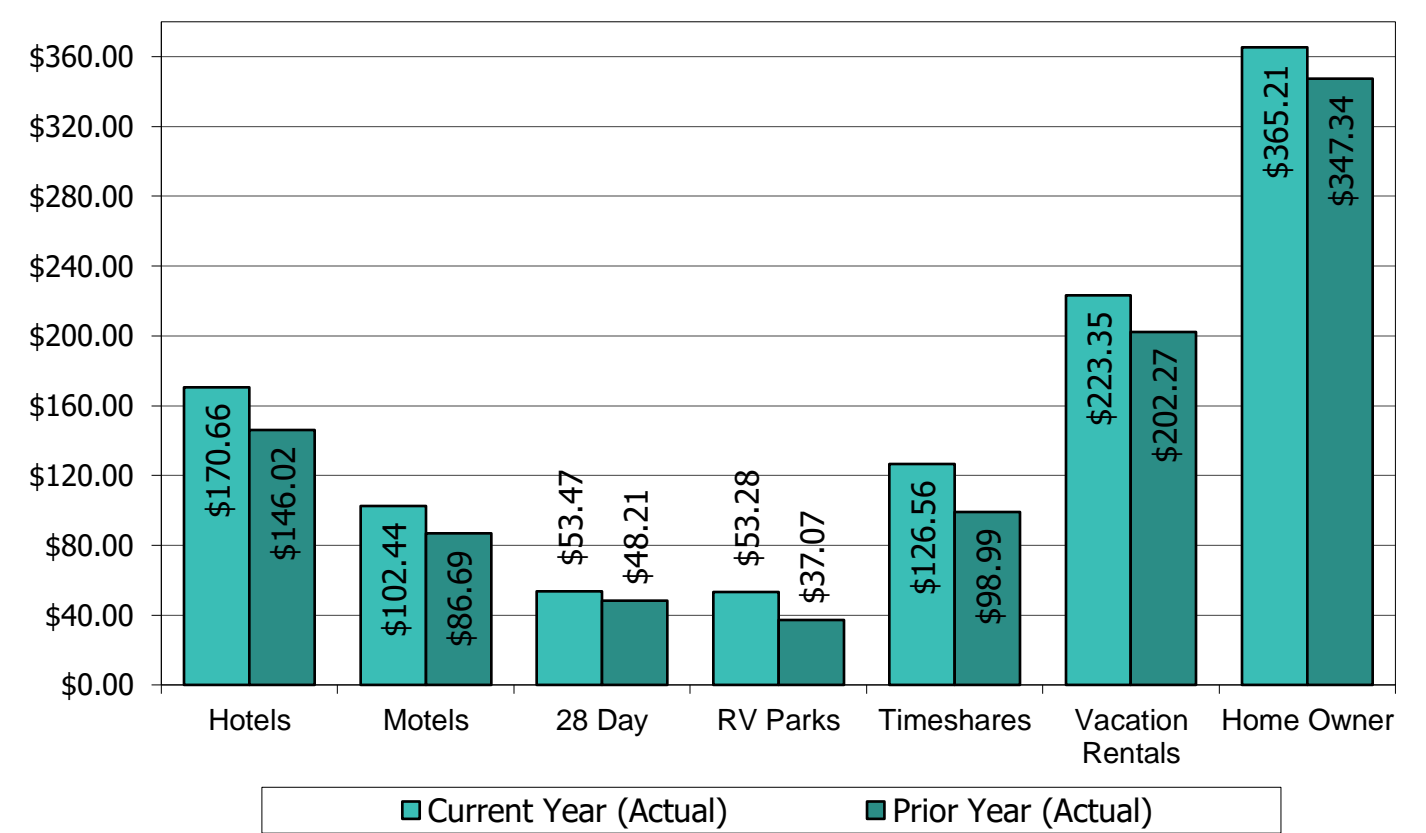
Year-to-date cash occupied room nights of 912,992 are 17,270 (-1.9%) below prior year. Cash average rates year-to-date of \$163.76 are \$12.14 (8.0%) above the prior year. Year-to-date, total taxable room revenues of \$149,508,494 are \$8,464,378 (6.0%) above prior year.
